- 2 <u>PURPOSES OF THE PROCESSING AND LEGAL BASIS:</u> Personal data you provided by filling the consignment form (name-surname-address-ownership) shall be processed for the following purposes, expressly requested by you: examination of the consigned work for the purpose of its filing in the Archive of Fondazione Lucio Fontana, if deemed as authentic; edition and re-edition of Catalogues Raisonees of the works of Lucio Fontana; Exhibitions in Museums and other institutions and related publications; legal basis for the processing is the consignement agreement you stipulated with Fondazione Lucio Fontana and processing will be functional to the execution of that agreement;
